EEF to host a DPRK Trade House

Alexander Krutikov, Deputy Minister for the Development of the Russian Far East, and Lee Gwang Geun, Deputy Minister of External Economic Affairs of the DPRK, discussed the concept of the Trade House.

The Trade House is to be set up on the territory of the Free Port of Vladivostok, and subsequently branches might be open in Moscow and Pyongyang.

The Korean party had submitted a list of export goods to be sold through the Trade House to the Ministry for the Development of Russian Far East, among which are produce, construction materials, medical supplies and equipment, perfumes, sewn products, electronics, clothing etc. There are also plans for the Trade House to hold an annual national expo of DPRK's goods and services.

Investment agreements worth 3.5 trillion roubles to be signed at EEF 2018

A round table of experts 'Investment Growth in the Far East in 2017 was 17.1%. How did we do it and what's next?' took place in Moscow on 24 April in the run-up to the 4th Eastern Economic Forum. The announced new mechanisms for the development of the Far East will presented at EEF 2018.

One of the blocks of the EEF business programme will feature 'industries of the future' that will provide economic growth for the region in the next 5–6 years. The traditional business dialogues with Asia-Pacific countries are to be complemented with round tables involving entrepreneurs from Europe, India, Vietnam and South Africa.

Chinese company to invest 2.7 billion roubles into a brick factory in Outer Manchuria

Songjiang Concrete Components company plans to build a fire and water proof brick factory with a capacity of two million tons per year. The project will be implemented in the Priamurskaya TOR (priority development area). The factory will require the development of raw cement deposits. Kolmar Company put into operation the Denisovskaya concentrating plant in Yakutia

A new plant with a processing capacity of 6 million tons of coal per year was launched in South Yakutia TOR (priority development area) within only 10 months. For a full plant feed the company plans to build a new Vostochno-Denisovskaya mine. For the first time in Russia a technology developed by the Chinese company Beijing CATIC Industry Limited was used for coal processing. This technology completely eliminates any negative impact on the environment. Carbonized coal will be delivered to domestic and export markets of the Asia-Pacific region.
