#### SPIEF 2018 discussed the development of the fishing industry in the Far East

On 26 May the session 'Catching the Goldfish: Sustainability Factors of Fisheries' of the St. Petersburg International Economic Forum 2018 emphasized the strategic significance of fishing industry for the development of the Far East. It was noted that the government's task today is to support the industry in implementing all the announced projects amounting to a total of nearly 40 billion roubles. Out of the 950 residents of the Free Port of Vladivostok and the territories of advanced development, 45 companies are currently developing projects in the fishing industry.

(Yelizovo) signed an agreement on investment operations in the Kamchatka territory of advanced development. The document stipulates the reconstruction of the airport, as well as the construction of a new terminal, hotel and business centre. The airport is anticipated to serve up to 750 passengers per hour. The project investments will exceed 7 billion roubles.

#### Primorye to build a coal terminal worth 30 billion roubles

The Far East Development Corporation and the Sukhodol Sea Port signed an agreement on investment operations, which stipulates the construction of the specialized port for small and medium-sized coal mining enterprises.

The first and the second stages of construction for 12 million tons of cargo are to be completed by 2021. Around 660 new jobs will be created through the implementation of this investment project.
