### NEWS FROM THE EASTERN ECONOMIC FORUM

**EEF 2018 Sees the Signing of 58 Agreements with International and Foreign Companies** The largest number of documents were signed with companies from China (31 agreements worth 290.6 billion roubles), Japan (16 agreements worth 1,591.1 billion roubles), and the Republic of Korea (9 agreements worth 9.5 billion roubles).

By the end of the forum, the 4th Eastern Economic Forum saw the signing of 220 agreements, contracts, memorandums, protocols, and road maps. Together, these documents are worth a total of 3.185 trillion roubles. The majority of these agreements are related to the socio-economic development of Russia's regions, industry and construction, international and interregional cooperation, banking, the fuel and energy complex, high technology and telecommunications, and the extractive industries.

### Russian Far East to Receive More Funds to Subsidize Passenger Flights

On 27 September, the Council of Ministers resolved to allocate additional subsidies from the Reserve Fund of the Government of the Russian Federation towards passenger flights in the Russian Far East. The subsidies are expected to total 400 million roubles, 300 million of which will go towards flights within the federal district, with the remaining 100 million allocated to flights travelling from the European part of Russia to the Russian Far East and back.
