

Tax Benefits for Far Eastern Investors to be Discussed at the EEF

First Foreign Tourists Received Electronic Visas to Visit the Far East

The free port regime may be extended to the international airports of Khabarovsk (Novy) On the first day the simplified regime came into effect 42 citizens of China and 38 citizens of Japan, as well as citizens of Algeria, Iran, Kuwait, Saudi Arabia, Singapore and Tunisia received their visas. Foreign nationals are issued single-entry business, tourist or humanitarian visas.

Foreign nationals may enter Russia on electronic visas through two checkpoints in Vladivostok: the maritime checkpoint and Knevichi Airport. Starting January 2018, four checkpoints will be in operation, including the Kamchatka Area and the Sakhalin Region.

Blagoveshchensk May Become a Free Port

The Ministry for Economic Development of Russia's Far East is planning to extend the Free Port Vladivostok regime. According to Deputy Minister for Economic Development of Russia's Far East Sergei Kachayev, extending the porto franco regime to Blagoveshchensk is planned as part of ongoing work on establishing special legal regimes for economic activities in the border territories and it will impact favourably not only on the Amur Region but the entire Far East as a whole.

China TO build an agroindustrial cluster in the Far East

The Tai Yuan Agroindustrial Cluster Russia—China joint venture is to invest over RUB 6 billion in the project. The new cluster will be constructed as part of Free Port Vladivostok. The complex's total area is 7,000 hectares, including five functional zones: headquarters, an agricultural sector for growing potatoes, grain and legume crops, zones for industrial processing, logistics and tourism. The project will have been implemented in three stages by 2024.

The First International Container Line to be Launched in Kamchatka

The project by Terminal Seroglazka, a free port resident, will allow for direct deliveries of fish from Petropavlovsk-Kamchatsky to the countries of Asia Pacific

The launch of a new container line and further development of the system of maritime container shipping will allow high quality of fish products to be maintained and delivery costs reduced by cutting costs of transshipments in other ports.

Currently, the investor is constructing an industrial cold storage facility with a capacity of 15,000 tonnes and is completing installation of a dockside crane and additional equipment for docking heavy-tonnage vessels. The overall volume of investments will be about RUB 876 million.

Russia's First Plant for Advanced Processing of Soy is Launched in the Amur Region

Amursky Oil Extracting Factory has been granted an operating permit. The project is being implemented in Belogorsk ASEZ with investments to the tune of over RUB 1.5 billion. Currently, 350 persons are employed at the plant. The first deliveries of the plant's products have already been shipped to the Urals, to the Western Siberian region and to China.

The plant is the ASEZ's first resident to avail itself of the free customs zone procedures allowing for significant cuts in project implementation costs.
