Extended Version of Third Eastern Economic Forum Business Program Published

On 6 September, the opening ceremony of the Forum will take place. Y. Trutnev, Deputy Prime Minister of the Russian Federation – Presidential Plenipotentiary Envoy to the Far Eastern Federal District, S. Swaraj, Minister of External Affairs of India, Nguyen Van Binh, Politburo Member, Central Committee Secretary, and Head of the Communist Party Central Committee Department for Economic Affairs, and other high-ranking official delegates from other countries will take the floor during the ceremony.

The EEF business program includes four main thematic blocks: "Economic Policy in Russia's East: What's Next?", "We Are Neighbours: Earning through Cooperation", "Doing Business in the Russian Far East" and "The Russian Far East: Creating a New Quality of Life by Responding to Challenges". Within the framework of the Forum, five inter-country business dialogues will be held: Russia-China, Russia-India, Russia-Republic of Korea, Russia-Japan, and Russia-ASEAN.

The central event of the EEF will be a plenary session "The Russian Far East: Creating a New Reality" with participation of President of the Russian Federation V. Putin, Prime Minister of Japan S. Abe, President of the Republic of Korea Moon Jae-in, and President of Mongolia K. Battulga.

The Moscow presentation revealed numerous cultural and sports events that will be held within the framework of the Forum. EEF's cultural program will be opened by the exhibition "Far East Street". The Primorsky Stage of Mariinsky Theatre will present the Sleeping Beauty ballet and the concert of the Moscow Soloists chamber ensemble founded by Yuri Bashmet. Russian and foreign artists will perform for the residents of Vladivostok during the Forum.

The central sport event will be the first J. Kano memorial international junior judo tournament under the patronage of V. Putin and S. Abe. There will also be a traditional marathon in defense of Amur tigers and Far Eastern leopards, a regatta, Far Eastern corporate games, ice hockey and basketball gala matches, mas-wrestling and tennis competitions.

Y. Trutnev Tells Rossiyskaya Gazeta about Commencement of Second Stage of Far East Development

According to the Deputy Prime Minister of the Russian Federation – Presidential Plenipotentiary Envoy to the Far Eastern Federal District, the second stage will aim at improving the quality of life of Far East residents, development of residential, social, and transport infrastructure. The first stage concentrated on developing and implementing new mechanisms for the region's development.

The Presidential Plenipotentiary Envoy underlined that currently 85 new enterprises are undergoing commissioning procedures in the Far East, 111 more are under construction and design. Today, for each budget ruble invested in the region development programs there are 20 rubles of private investments.
