

EEF 2018 dates set

The fourth Eastern Economic Forum will take place on 6–7 September 2018 on the campus of the Far Eastern Federal University on Russky Island, Vladivostok. The Forum will kick off on 5 September with a Youth Day.

At the first meeting of its Organizing Committee, Russian Presidential Envoy to the Far Eastern Federal District Yuri Trutnev issued a number of instructions relating to preparation of Vladivostok's city infrastructure and hotel accommodation, as well as the Forum venue. Special instructions were issued with regard to the cultural and sports programmes, including the Jigoro Kano Under-21 International Judo Tournament and the Far East Street exhibition. A track dedicated to development of human capital in the Far East will be given more emphasis in the business programme.

Investment in the development of Russia's Far East tops RUB 3.3 trn

Russia's Minister for Development of the Far East Alexander Galushka said during a 'government hour' at the Federation Council that the investments are backed up by more than 950 investment projects that will create 115,000 jobs by 2025. 73 new enterprises have already started operating. Some 280 projects will be launched by 2020, including manufacturing plants, logistics centres, and agribusinesses.

An industrial fisheries cluster slated for Nadezhdinskaya PDA

The Primorsky Krai cluster will consist of a manufacturing facility complete with a machinery section and a processing shop, a refrigerator, and a fish waste processing facility. At the second stage, construction of a 20,000-tonne-a-year frozen semi-prepared foods plant and a fish feedstock plant to supply aquaculture companies is scheduled. The first stage is expected to become operational by the end of 2019 and the second from 2021 through 2022.
